I am to draw your attention to this Office Lr.No.1-104[10]/2014/NVS/BPL/SA Dt.27.10.14 and subsequent letter dtd.22.8.14 wherein you were asked to furnish the details of employees in the prescribed format [Annex.1,2, & 3] mentioning the details of membership of employees through check off system indicating the details of subscription to this office for furnishing the required consolidated data to Samiti Hqrs. in connection with recognition of Service Association of employees of NVS.

In this context, it is to inform you that though this office is in receipt of details from almost all Vidyalayas, it has been observed that in some cases the information under column 6 & 7 of Annex.III of this office ibid letter dt.25.7.14 did not received from the following Vidyalayas on the grounds that though the authorization letter from the employees concerned have been received for membership,the subscription could not be deducted from the salary of Aug.2014 with the mention that the same will be deducted from the salary of Sept.2014.

The above JNVs should furnish the data i.r.o Col.No.6 & 7 after verifying the deduction from the salary for the month of Sept.14.

Further, it is observed that the name of the Association claimed by the employees is found as All India NVS Staff Association [AINVSA], except few employees has not indicated the 'Group' they want to associate with specially under 'AINVSA'. As a result of this, this office could not furnish the consolidated data under AINVSA [Groupwise] to the Samiti Hqrs.

Now the Samiti Hqrs. has therefore, directed this office to furnish the data including the number of staff members opted for various Association – [Groupwise in the case of 'AINVSA' i.e. LB Reddy, Group or Mani Group separately] enrolled through check off system in the revised new Format enclosed herewith.
