### Sub: Resolutions adopted on 8-5-2013 in the annual CEC meeting

#### Dear friends

The Central Executive Committee of AINVSA organised its annual meeting in the headquarters of STFI, New Delhi on 8<sup>th</sup> May 2013. It was attended by 44 active members of the Association. The post nation-wide indefinite strike scenario and various other issues that demanded immediate attention of the Association were discussed.

At the end of the one-day long meeting the following resolutions were unanimously adopted.

1. It was proposed to send a charter of demands to all the concerned authorities with a request to resolve them in a time bound programme.

The letter with a charter of demands is enclosed herewith. All vidyalaya units are requested to send a signed copy to 1) The Secretary, Dept. of School Education and Literacy, Govt. of India, Sastry Bhavan, New Delhi and 2) The Commissioner, Navodaya Vidyalaya Samiti, Noida, UP by speed post. A signed copy of charter of demands may also be sent to AINVSA CEC, Jawahar Navodaya Vidyalaya, Mamnoon, Warangal Dist., A.P. by ordinary post.

2. It was resolved to strengthen the Association from the grass root level, the state level conferences would be held from July 2013 to Feb 2014.

The President and Secretary of the AINVSA of their respective states requested to decide and intimate the Association of the state level conference of the Association at the earliest and inform the CEC. Arrangements may be made to invite prominent leaders of local service Associations/Organizations.

3. The CEC also resolved to build up an active cadre based Association. For this cadre with a commitment would be nurtured.

The state committees should identify the active members of Association and take them into state level executive committees.

4. The CEC has also resolved to strengthen the state committees and CEC financially. The vidyalayas from which no contributions were received would be appealed once again to help strengthen the Association financially.

The vidyalaya units which have not yet contributed monetarily for the membership and strengthening the Association are requested to collect an amount of Rs.200 from each member and send the demand draft drawn in favour of ..... to AINVSA, CEC, WARANGAL.

5. The CEC resolved to release a souvenir on the occasion of VI national conference. The state and CEC would actively work out a strategy to get advertisements which would go a long way in strengthening the activities of the association financially.

The members of the Association are requested to contribute to the souvenir in the form of poems, stories, articles on education, CCE, NVS system, Foreign Direct Investment, etc. The

State Committees have to make efforts to collect advertisements, which will ease us to meet the expenditure to prepare and release the souvenir.

6. The CEC resolved to fight all out to win the pension case.

The pension case filed by the Association has been taken as a lead case and the petitions of Shri P.N.Mishra and Shri Khanna and others will come for argument along with the Association's petition. While the Association is going all out to win the case, it requests the members to contribute towards meeting the necessary expenditure to the case. We should realize that we can not afford to lose the case for want of funds.

7. The CEC also resolved to complete 100% membership drive.

The State CECs should review the membership drive once again and contact the vidyalayas from where the Association has not received the membership forms. They may also contact the neighbouring state vidyalaya and urge them to form vidyalaya units and take membership at the earliest. The CEC feels that no school should go unapproached for this purpose.

8. It was also resolved that the vidyalaya units would expedite verification of membership in July & August. Necessary guidelines would be put on the website.

A sample letter is being sent along with this letter and all vidyalaya which have enrolled already/are enrolling/will enroll may fill it send one copy to the Commissioner, NVS, Noida and one copy to CEC, Warangal.

9. It was also resolved to organize the VI national conference in the first /second week of February 2014.

Efforts are on to organize the VI national conference of the Association inviting the Union HRD Minister, the Commissioner, other VIPs and leaders of service Association. The conference is expected to give a new direction to the Association and garner more support and strengthen the Association

10. The CEC also resolved to affiliate the association to the School Teachers Federation of India (STFI) to gather more support to its activities.

11. The CEC also proposed to have its own office in Delhi.

In the best interest of the members and further strengthening the association it was decided to own an office in New Delhi as is usually done by other service Associations. The financial matters will be chalked out in due course of time

12. The CEC also resolved to take in Shri. J.K.Singh creating the post of the working president of the Association.

The Association recognizes the services of Shri J.K.Singh and his contribution as JAC member in leading the nation-wide strike. A post of Working President has now been created to further strengthen the Association and decided to use his service in that capacity.

13. Finally the CEC approved the secretary's report submitted to the CEC unanimously.
