## **SUB: Issue of Guidelines to DDO`s regarding deduction of subscription of membership fee.Regarding.**

Following your letter dated 19-02-2014 and the Officer memorandum issued by the Deputy Commissioner intimating the adoption of the CCS Rules (RSA) 1993 and initiation of the proceedings for the recognition of an association, the All India Navodaya Vidyalaya Staff Association (AINVSA) applied for recognition through its letter dated 13.03.2014

We have learnt from various schools that the staff have submitted their authorization letters to the DDOs. But the recovery of the subscriptions has not been taken up by the DDOs in the absence of further guidelines by the Navodaya Vidyalaya Samiti.

You are humbly requested to issue guidelines to the DDOs immediately to allow the recovery of the subscription fee from the pay rolls and collect the data of membership from the regional offices to identify the association that represents a minimum 35% of the staff and accord it recognition without further delay.

Kindly issue time bound instructions to the Regional offices and the DDOs so that the whole exercise is completed at the earliest.
