Sub: Formation and Registration of a new association

Respected Sir

Responding to the letter from the Deputy Commissioner (Pers), NVS, Noida dated 19th February 2013, the Association under the leadership of Shri Jagdish Rai (Former President) and Shri L.B.Reddy (Former General Secretary) submitted the membership forms of over 12000 teaching and non-teaching staff working in the NVS and requested the management to bring the exercise of recognising service associations as per CCS RSA Rules (1993) in NVS to a logical conclusion. Our Association had secured a membership of nearly 70% of the total number of employees working in NVS and truly deserved recognition.

However, the management has given weightage to Shri T.P.Mani's group which had not even secured one per cent membership of the employees working in NVS at that time and addressed the issue of authenticity of the association to the Registrar, Kottayam.


At the request of the NVS, the Registrar of Societies, Kottayam asked us and Shri T P Mani to appear before him in person with the documentary evidence to prove the authenticity of the ownership of the association. In the later months in addition to submitting huge documentary evidence in our support, we also exposed the faked and forged documents of Shri T P Mani in support of his claims.

It is sad to see NVS still insisting on a patch up with a group which enjoys no support of the staff and has even indulged in faking and forging documents to prove their continuation as an association as legal. The CEC Meeting held on 09-10-2017 at Delhi did not give its consent to any patch up with Shri T P Mani's group as it was unanimously felt that such a gesture would authenticate the dubious methods adopted by Shri T P Mani in support of his claims for the ownership of the association and his several other anti-employee actions. In the same meeting it was unanimously proposed to register a new association with the name ALL INDIA NAVODAYA VIDYALAYA SAMITI STAFF ASSOCIATION (AINVSSA). However, due to the changes in the registration act, the same name had not been approved by the Registrars across the country. Finally with the approval of the Central Executive Members, a new association with the name ALL NAVODAYA VIDYALAYA SAMITI STAFF ASSOCIATION (ANVSSA) has been registered at the office of the Registrar, Kakinada, East Godavari District (A.P.). Its registration number is 639/2017. The future correspondence of the association will be started with this new name and on a new letter pad. Through this letter We would like to inform you that the old name of the association – All India Navodaya Vidyalaya Samiti – stands cancelled. A letter to the Registrar, Kottayam has also been written to this effect with a request not to permit Shri T.P.Mani or any other group to use this name as Shri T P Mani has already failed to appear before him in person to prove his credentials as the legal president of the association. He is also bound to prove that he had not faked and forged the submission to the registrar if he wants to use the old name. Our Association will take a legal action against anybody who tries to use the old name – AINVSSA.


