CIRCULAR REGARDING CONTRIBUTIONS

Dear friends,

The CEC has appealed for monetary contributions from the Association members recently. Over the years many allegations regarding money matters were repeatedly made against us though we did not appeal for funds frequently. We honour everybody's right to express his dissent and doubts but it is not always possible for us to answer the false allegations. What was unfortunate was such comments had to be faced at times when we were seeking the support of all including those few who had not given their old loyalties to Shri T. Mani. Answering the allegations strongly would displease these sensitive sections of people who we feared would be discouraged from participating in the nation-wide indefinite strike. Besides answering them itself was too consuming and we had little time to spare for such unwanted business. In the larger interest of the agitation we decided to ignore them. Actually a careful reading of such circulars itself should help one understand the malicious intentions behind them. A crafty use of language without proofs is enough to spread the seeds of doubt. These rumormongers know that their loyal followers won't demand for any evidence. Keeping them guessing with ambiguously thrown hints is the sole purpose of such nasty propaganda. We mention a few lines from Shri T P Mani's letter dated 1st February:

It is true beyond any doubt that Sri. Sri.L B Reddy could not get a share of the porridge from Sri.P N Mishra. (*What strong evidence did they have about Shri L B Reddy asking for 'share of the porridge from Shri P.N.Mishra? If he really asked for a share of the porridge, how could Ranchi school dole it out without intimating anybody? If it all he demanded for a share of the porridge, what did he want the money for? Shri T P Mani should have asked himself such questions and gave more information along with his allegations to make them more convincing. As usual he was happy with making allegations. We wonder how long will this man allow himself misuse his reputation as one of the founders of the organisation.*)

.... his idea (Shri L B Reddy's) was to hold dharnas and maha meeting and facilitate the flow in and out of money. (*Is this the reason why Shri T P Mani does not encourage 'dharnas and maha meetings'? Kudos to him for planning to run an association without any nation-wide conferences. Does he think that his CEC members doesn't need to be elected or renewed? What mechanism has he got for the election of the CEC members without 'maha meetings'? If he could suggest a measure through which the Associations and organizations elect their CEC members without a national level conference we will be highly obliged to him. As to the 'flow in and out of money', does he think we have been running this organization without a proper accounting procedure of the funds collected and the expenses incurred?)*

The above letter makes several other baseless allegations but we believe that the indefinite strike has answered many of them and exposed the true colours and strength of Shri T.P. Mani and, hence, we desist from giving a full length reply to his letters. We only hope that Shri Mani and his too loyal supporters will make a true introspection of themselves and realize that they that they have stopped enjoying the support of the staff just because their inaction and malicious propaganda against us. As to ourselves, we will not be letting ourselves provoked by the baseless allegations in future as there are many other issues to attend.

It is in this background of misgivings about monetary contributions we are once again appealing to you all the necessity of funding the Association to help it serve you better. We feel it is also important to enlighten the members as to why the funds are raised and how they are spent by the Association.

1. Firstly, a nation-wide organization cannot be run without subscriptions from its members. Hence, regular subscriptions should be collected members. The Association charges a yearly subscription of Rs.100 from each of its members. The vidyalaya units should collect this amount from its members annually, i.e. from the date of an employee filling in the membership form and formally joining the Association. As per the by-law the membership has to be renewed every year. But the CEC will make necessary amendments to this clause keeping into account the practical difficulties.
2. Of the contributions raised at the vidyalaya level should be sent to the CEC. Each vidyalaya has to open a savings bank account in any nationalized bank in the name of AINVSA vidyalaya unit. This account should be jointly operated by secretay and treasurer . The expenses incurred by the vidyalaya unit may be audited SEC. The objections, if any, will have to be ratified by the executive body itself at the earliest.

Similarly, the SECs will also have to open an account in any one of the nationalised banks in the name of AINVSA, SEC and its details may be circulated to all the vidyalaya units. Their expenses will have to be audited by CEC. The objections, if any, will have to be answered to the satisfaction of CEC. The details of expenditure and auditing particulars may be circulated soon after the annual SEC meeting to all the vidylaya units in the form of a statement.

The CEC has already opened an account in the Union Bank of India, Warangal in the name of AINVSA, CEC. This account is jointly operated by General Secretary and Treasure. . The A/No **346802010010580** and the IFSC code of the bank is UBI NO534684. As per the by-law, the expenditure incurred by the CEC is submitted to the annual CEC meeting for auditing.The CEC also will have to answer the objections raised by the auditing persons and all these details have to be sent to the Charity Commissioner .A statement of the accounts in the Excel form will also be put on the website for the perusal of all at the earliest.

At this juncture we would like to bring to your attention that the Association faced severe monetary crunch many a time in the past which also weakened its efforts to strengthen the Association and fight for the concerns of the staff.

3. The Association requires physical amenities like a desktop computer, broadband connection, landline, printer, a table or two and a few chairs. It requires a part-time computer operator who can attend to typing of circulars, receiving mails, sending mails, taking prints, posting letters, and a few miscellaneous jobs. We have to run all this business so far thanks to the voluntary and uncomplaining help rendered by the vidyalaya regular staff. At present and in future also the Association will continue toutilize their services. But it is not sensible to burden them all the time. Hence, it is proposed to take in a part-timer who can handle the above jobs accepting a reasonable minimum payment. Besides this honorarium to be payable to an individual, we should also meet expenses of the telephone bills, postal charges, internet charges, stationary expenses, propaganda material etc. The preparation and issue of ID cards also demands some expenditure.

4. The Association has also grown in numbers now and this is necessitating the running a fortnightly/monthly magazine to provide a literary platform to the staff to express their ideas, opinions, agony, problems, etc. Shri Shaik Maruf, President, SEC, Maharashtra has proposed and expressed his willingness to look after the printing of the Association's magazine. The CEC is happy with his proposal and expects to chalk out a plan in this direction.

4. The Association also depends on your subscriptions alone to use the RTI act to obtain information from the Management regarding various issues from time to time. In the past we sought information from the NVS regarding the promotion of the TGTs and the implementation of the promotion policy. There are several other issues which should be made public and using RTI will help us a lot.
5. The TA/DA expenses of the CEC members have to be met from the subscription shares sent by the vidyalaya units only.
6. The Association also conducts seminars, workshops, and organises dharnas, rallies, meetings, conferences at national level. Without your monetary contributions it will be difficult to strengthen the Association and expose our demands democratically.
7. The Association also needs to meet its expenses for its legal battles partially from the subscriptions. The Association has filed two cases – CCS Pension case in the hon'ble SC and MACPS case in the CAT, Delhi. Hence, you all have been asked to contribute Rs.100 more for court cases alone in addition to your subscription fee for the current year. If you have already paid the subscription fee for the current year, kindly ignore our call.
8. The Association also needs to extend monetary help the members and their families in times of chronic illness, untimely deaths, etc.
9. There have been many suggestions from the members to engage a legal adviser for the association. The CEC is giving a serious consideration to this. If a legal adviser is to be taken in, she/he needs to be paid some honorarium.

We appeal to all the members to discuss the contents in a general body meeting of the vidyalaya unit and cooperate with the CEC and collect Rs.200 from each member and deposit in the account of AINVSA at the earliest.
